



2017 CONTINGENCY AWARDS PROGRAM

The Lucas Oil Regional Off-Road Series, Arizona was developed in 2009 and became an addition to the Lucas Oil Products extensive family of racing series in 2010. This regional series acts as a feeder series to the largely successful Lucas Oil Off-Road Racing Series (LOORRS). The goal is to bring affordable grassroots short course racing to fans, sponsors and racers in Arizona.

We invite you and your company to join the Lucas Oil Regional Off-Road Series, Arizona's continued growth by participating in our Contingency Program.

You choose your award (cash, product or both) and define your own qualifications. You choose which class/classes and what positions you would like to award in each class. The only requirements are as follows:

- A minimum of \$250 cash or product must be awarded per event.
- Contingency Sponsors must participate in all 2017 events (*exceptions made only as part of a customized sponsorship package*).
- Must send a supply of your decals 2 weeks prior to the beginning of the 2017 season and as needed.
- A high resolution logo for use on our website in the Contingency Sponsor page.
- Awards must be paid out to drivers as promised.

Lucas Oil Regional Off-Road Series, Arizona will ensure all Contingency Sponsored drivers meet all the requirements prior to the Main Events, will submit an email reporting all race results no later than 2 weeks following the race event and ensure the Contingency Form is completed and submitted to a representative by each driver prior to the event.
